JA BizTown /JA Finance Park is open for business!

JA BizTown welcomed our first group of 5th grade students from Arlington Elementary on January 10, 2017. During the first two weeks of operation, the following schools served as "pilots"– Collins Lane and Bridgeport (from Franklin County) and Fayette County's Arlington and Veterans Park Elementary schools. Arlington and Veterans Park had experienced JA BizTown during the 2015-2016 school year when they visited the JA BizTown facility in Louisville.

Over 160 guests attended our official grand opening on March 7th. Following the main ribbon cutting just outside the doors leading into JA BizTown, each storefront partner had the opportunity to "cut the ribbon" opening their JA BizTown store. Learning opportunities begin in the lobby of the JA BizTown/JA Finance Park facility where students are able to visualize the economic impact and available employment opportunities in both the equine and agricultural industries.

The culmination of 12 lessons in the classroom, the JA BizTown experience offers 5th grade students a unique opportunity to enjoy a "work day" experience where they will discover the real-life opportunities available in the free enterprise system.

Prior to their arrival at JA BizTown, students are assigned a job in one of the businesses. They may be the Mayor of JA BizTown, the President of Forcht Bank, the CFO at UPS, a doctor at UK Healthcare, the quality control manager at Toyota, the admissions officer for UK, the meter reader at Kentucky Utilities, the nurse at KentuckyOne Health, the on-air personality for LEX 18 or the disc jockey for the radio *continued next page*

station. During a typical day at JA BizTown, students receive and deposit paychecks, conduct staff meetings, discuss marketing plans, take breaks and have the opportunity to be consumers by making purchases in one of the business-sponsored storefronts.

The summer months offered opportunities for 4th-6th grade students to experience JA BizTown during a week-long summer camp. Approximately 35 campers enjoyed the camp held during the week of June 19th. One of the highlights of the camp was the "Day Without Water" program sponsored by KY American Water. This activity illustrated the impact water has on our everyday lives.


JA Finance Park will be available to Central Kentucky 8th grade students during the 2017-2018 school year. This program provides a practical, hands-on personal budgeting simulation for middle school students. While experiencing JA Finance Park, 8th grade students learn about the implications of financial decisions, consider the options available and construct and live within a personal budget. The classroom curriculum is complemented by a visit to the Park, where students immerse themselves in a reality-based decision-making process addressing individual and family budget considerations such as housing, transportation, food, utilities, health care philanthropy and banking.

In preparation for the opening of JA BizTown/JA Finance Park, Junior Achievement of the Bluegrass (JA) increased its county footprint from eighteen to thirty-six. This expansion allows JA to inspire a greater number of students throughout Central and Eastern Kentucky to dream big about their future and understand what skills they will need to reach their potential.

Junior Achievement of the Bluegrass has been serving Central Kentucky since 1963. 



Haley Flynn is a 5th grade student at Athens-Chilesburg Elementary School. The school's 5th grade teachers taught the JA BizTown curriculum and then came to JA BizTown for the student's work day simulation. Haley was selected to speak during the 2017 Bluegrass Business Hall of Fame to describe her experience as the CFO of the University of Kentucky. Below are her remarks:

Hello! My name is Haley Flynn and I am a JA Ambassador from Athens-Chilesburg Elementary. When I went to JA BizTown, I

worked in the University of Kentucky. At UK, we offered a guiz that our fellow citizens took to earn a diploma. To get the diploma, you had to pay \$4.75. The other citizens could also buy a UK bag with Wildcat based goods. At the end of the day, my business had a total revenue of \$191.43 and a profit of \$86.43. While working at UK, I was the CFO. As CFO, my main responsibility was to manage my company's money. I also printed the paychecks, collected the invoice fees from other businesses and deposited all the money my business earned into the bank. Even though I had to do all these very stressful, important jobs, I had a blast doing it!

My favorite part of the day at JA BizTown was when my coworkers and I paid off our loan. When we saw that the bank had approved that Administration, Eric Monday, during JA's we have successfully paid off our loan, relief was on everybody's face, even our volunteer. We all knew that all the hard work, stress and sweat was worth it. We were only the 5th

was stressful! If I inserted one thing wrong, it would be ruined and that's a little like what happens in the real economy today.

> The work in the classroom leading up to JA BizTown was very detailed and challenging. We were learning and talking about JA BizTown for about 12 weeks. We learned how to fill out check registers, checks, deposit tickets and more. The last week before going to JA BizTown, we had a lot of discussions with our business team about prices, ads and what goods we're selling. Though the preparation was long, it was worth every second. If I ever get the job opportunity to be the UK CFO, I would gladly take it. I love the feeling of being important and having all the money in my hands. It has always been my dream to become a UK Wildcat, playing soccer, going to college there or even working there someday.

> The most important thing I learned at JA BizTown about the real world that I hadn't known beforehand was that the circular flow of the economy actually makes a difference in the business world. Without it, no one would

JA BizTown made me feel like an adult because I had an actual job at an actual place that was really successful. I was depended on to make sure all my employees got their paychecks and man that

"Mr. Roberts has regularly volunteered at Henry Clay over the last several years, and we had the pleasure to have him teach our classes this year. He is comfortable working with a variety of students ranging from the high performing students to some of our most challenging special education students. Some of the students in our class come from very challenging backgrounds, but Mr. Roberts was able to listen to their perspectives and help them apply what they were learning in JA to their lives. His impact over the years has been significant and important and he is the living example of businesses working with schools to make our communities a better place," say Riley and Cabble.

John Hibbard, a Franklin County volunteer, has worked alongside teachers at Peaks Mill Elementary for the past nine years. Hibbard has been named the 2017 Volunteer of the Year for the outlying counties served by Junior Achievement.

He was nominated by Elya Ebert, a 4th grade teacher at Peaks Mill Elementary. "Mr. Hibbard has volunteered in my classroom for the

past two years as a JA volunteer. During this time, he not only taught the JA content well, but also had a positive impact on the students by encouraging them to make good life choices. Along with his dedication to the students during his visits, he is always prepared and punctual. When he arrives, he is enthusiastic which instantly gets the attention of the students. He does a wonderful job of keeping the students' attention and maintaining control during his lessons," says Ebert.

2017 Teacher of the Year

Jennifer Davis, an elementary school teacher at Yates Elementary in Lexington has been named the 2017 JA Teacher of the Year. Davis has had Junior Achievement programs in her classrooms for the past five school years.

She was nominated by JA Volunteer Kim Gentry. "I have taught several JA classes at multiple schools, and Mrs. Davis has been the most refreshing teacher I have ever worked with. She participates and is active in each lesson and brings personal experiences into them. This shows me she prepares by reading the lesson beforehand. Her communication with me has been second to none. She always emails me the day before to see if there is anything special that I need for the next session and if there is anything that she can do to prepare for my arrival. It is clear when you walk into Mrs. Davis's class that her class adores her and she has always prepared them for your visit," says Gentry.

Bluegrass Apprentice Competition Offers High School Students the Opportunity to Showcase Their Entrepreneurial Spirit

Students from Tates Creek High School, Lafayette High School, the Steam Academy and the Lexington Christian Academy competed in the 2017 Bluegrass Apprentice Competition, held in partnership with the Lexington office of The Kentucky Innovation Network.



In preparation for the competition, students worked for months to conceive, research, and develop their business plans. They then competitively pitched enterprising ideas for products or services to the "sharks," or judges. The "Sharks" consisted of prominent members of the Lexington business community, including Toa Green, Crank & Boom Ice Cream Lounge, Patrick McGee, Churchill McGee, LLC, David Kidd, PNC Bank, and Joe Ross, North Lime Coffee & Donuts. "This was really a great experience and a wonderful opportunity for the kids to present their ideas under pressure. I really enjoyed getting to hear their ideas and give feedback about opening and operating a business," said Toa Green. "Having a program like this is really vital in getting kids involved at a young age." The top 3 winning teams walked away with cash prizes valued up to \$750, provided by the Lexington office of the Kentucky Innovation Network.

Prior to the event, students completed a seven-week JA curriculum entitled, "JA Be Entrepreneurial." This curriculum, taught by volunteers from the Bluegrass business community, introduces students to the essential components of a practical business plan. The JA Bluegrass Apprentice competition is designed to help these students become more competitive and adaptable in a constantly changing business environment. The students are encouraged to 'think entrepreneurially'- to provide solutions to their generation's challenges, whether they jumpstart their own ventures, or add value by working for someone else.

Top honors were taken by a team from Tates Creek High School, who created Roll-Up Sushi, a sushi delivery restaurant. Major sponsors of the 2017 Bluegrass Apprentice competition were Churchill McGee, LLC and PNC Bank.

ADOPT-A-SCHOOL PROGRAM

The Adopt-A-School program allows companies to partner with a particular school by funding at least ten classes impacting as many as 200 students through JA's financial literacy and work readiness curriculum. The companies underwrite the program materials for each classroom, along with the volunteer training, support and evaluation. When possible, the sponsoring company offers 10-12 classroom volunteers to deliver the JA programs.

UPS FOUNDATION AWARDS GRANT TO JA OF THE BLUEGRASS

A partnership between Junior Achievement of the Bluegrass and the UPS Foundation launched an entrepreneurship program to benefit local high school students. For 2017, UPS awarded a \$7,300 grant to provide a minimum of five classes of the JA Be Entrepreneurial curriculum. This program focuses on challenging students, through interactive classroom activities, to start their own entrepreneurial venture while still in school and assists students in developing their entrepreneurship knowledge and skills. It provides the tools to develop a business plan and inspires students to take innovative action to successfully compete in the marketplace. These dollars allowed Junior Achievement to provide this curriculum to 167 students in six high school classrooms.
